2025-2026 Financial Aid Appeal

If you're not meeting Satisfactory Academic Progress (SAP) for financial aid, you can submit an appeal due to:

- Illness or injury
- ✓ Death of a relative
- Other special circumstances OR
- ✓ Maximum Timeframe > 150% of the required credit hours. Please provide a signed copy of your DegreeWorks (degree plan).

To submit an appeal, you must:

Provide a statement on a separate sheet of paper explaining what happened (why you didn't meet SAP and when it occurred). Describe improvements (how your situation has changed and what you'll do differently). Provide documentation (proof of circumstances like medical records, death certificate, or official statements).

☆ IMPORTANT NOTES:

<u>Appeals without supporting documents won't be approved.</u> Processing takes up to 2 weeks (or longer during peak times). You must pay tuition on time while waiting for a decision. If approved, you'll be placed on Financial Aid Probation and must meet conditions to regain good standing. **Student Financial Services' decision is final.**
