## **Required Documents**

#### If 2024 income is lower than 2023

Submit the following:

- 1. A statement explaining why 2024 income was lower (e.g., job loss, employment change). Include dates.
- Signed copies of 2023 tax returns (if not imported from IRS to FAFSA).
- Signed copies of 2024 tax returns.
- 4. If due to a **parent's death**, include the death certificate.
- If due to a divorce, include the final divorce decree.

#### If 2025 income is lower than 2023

Submit the following:

- 1. A statement explaining why 2025 income will be lower. Include dates.
- 2. Signed copies of 2023 tax returns (**if not imported from IRS to FAFSA**).
- 3. Signed copies of 2025 tax returns (available February 2026 or later).
- 4. A statement from the employer on company letterhead, including:
  - Employment start and end dates
  - Hours worked per week
  - Rate of pay
- 5. If an employer cannot provide a statement, submit a personal statement with the same details.
- 6. A copy of the last **2025 paycheck stub** from all jobs, showing year-to-date wages.
- 7. A **Texas Workforce Commission** printout of unemployment benefits received in 2025.
- 8. If no unemployment was received, complete the **Monthly Income** section on page 2.
- 9. If due to a **parent's death**, include the death certificate.
- 10. If due to a **divorce**, include the final divorce decree.
