Required Documents

If 2025 income is lower than 2024

Submit the following:

1. A statement explaining why 2025 income was lower (e.g., job loss, employment change). Include dates.
2. Signed copies of 2024 tax returns (**if not imported from IRS to FAFSA**).
3. Signed copies of 2025 tax returns.
4. If due to a **parent's death**, include the death certificate.
5. If due to a **divorce**, include the final divorce decree.

If 2026 income is lower than 2024

Submit the following:

1. A statement explaining why 2026 income will be lower. Include dates.
2. Signed copies of 2024 tax returns (**if not imported from IRS to FAFSA**).
3. Signed copies of 2026 tax returns (available February 2027 or later).
4. A statement from the employer on company letterhead, including:
 - Employment start and end dates
 - Hours worked per week
 - Rate of pay
5. If an employer cannot provide a statement, submit a personal statement with the same details.
6. A copy of the last **2026 paycheck stub** from all jobs, showing year-to-date wages.
7. A **Texas Workforce Commission** printout of unemployment benefits received in 2026.
8. If no unemployment was received, complete the **Monthly Income** section on page 2.
9. If due to a **parent's death**, include the death certificate.
10. If due to a **divorce**, include the final divorce decree.
