SCHOLARSHIP CRITERIA:

All Applicants Must:

- Be a U.S. Citizen or legal permanent resident with a permanent resident card or passport stamped I-551
- Have a permanent residence in the City of Mission at the time of the application and for 2 or more consecutive years prior to submitting the application and remain a resident while attending South Texas College
- Have completed a high school diploma or its equivalent before submitting the application
- Have earned at least 6 credit hours with a 2.5 cumulative institutional GPA

AVAILABLE SCHOLARSHIP PROGRAMS:

- Part-Time Student Scholarship: Enrolled for a minimum of 6 credit hours during each semester for a maximum of 8 semesters.
- Full-Time Student Scholarship: Enrolled for a minimum of 12 credit hours during each semester for a maximum of 4 semesters.

Scholarship awards based on credit hours:

- 12 credit hours - \$800.00
- 9 credit hours - \$600.00
- 6 credit hours - \$400
